BG SAFE SRL. is acceptable to this Administration to conduct in presence of an attending class society surveyor the annual and five year thorough examination and servicing of all of the lifeboats, the lifeboat launching appliances, and the on-load release gear on board the CIELO DI DUBLINO and the CIELO DI SAN FRANCISCO in accordance with provisions of SOLAS reg. III/20 and MSC.1 Circular 1206 subject to the following conditions:

1. The manufacturer's service and maintenance manuals must be available on board for the lifeboat, lifeboat launching appliance and the on-load release gear.
2. The facility's procedures for the thorough examination, servicing, and testing of the lifeboat, lifeboat launching appliances, and on-load releasing gear must be acceptable to the attending class society surveyor.
3. All testing, repairs, and maintenance to the lifeboat, lifeboat launching appliances and on load releasing gear must be carried out in accordance with the manufacturer's instructions and manuals, the instructions required by SOLAS Reg. III/36, and to the satisfaction of the attending class society surveyor.
4. The class society is satisfied with the qualifications and knowledge of the personnel conducting the test

Upon completion of the examination, servicing, and applicable testing, BG SAFE SRL. shall prepare a written report of the thorough examination and tests and give it to the attending class surveyor. A copy of this report should be maintained on board the vessel.

This authorization of BG SAFE SRL.is valid only for the thorough examination, servicing, and testing of the lifeboat, lifeboat launching appliances and on-load release gear on board the CIELO DI DUBLINO and the CIELO DI SAN FRANCISCO during this current survey.
